Party-2: Sharing professional expertise by means of deputing 2 college faculties namely-Prof. (Shri.) Gajanan Bansod and Prof (Smt.) Veena Kakade without any financial liability on Party-1 against compensation towards the institute and or faculties, engaged in the collaborative project, towards professional fees / institutional admin fees; Financial obligation none unless specified hereinafter or amended later during the period of MoU.

C. Specific responsibilities / deliverables by Parties:

Responsibility of party-1:

- a. To provide operational and logistic support for implementation of study project activities.
- b. To collaborate with other NGO partners to seek technical support.
- c. To supervise and monitor project activities.
- d. To engage required workforce for the project activities.

Responsibility of party-2:

- a. To depute two college faculties as names specified earlier.
- b. The faculties to facilitate / participate core team meetings / workshops / trainings planned under project.
- c. The faculties to provide professional expertise to teams of Party-1 as and when required.
- d. The faculties to undertake Review of Literature (RoL) with reference to study project and actively participate in preparing study report.

D. Scope for Visibility and Credits:

- a. All the display – printed materials including study tools will carry logo and names of both the parties with equal visibility along with other collaborators / partners / donors.
- b. The faculties will be regarded as co-investigators along with principal and co-investigators involved / engaged / participated / contributed in the Study Project; the due credits will be awarded in final report and any publications thereafter.

E. Property rights:

Party-1 will remain the sole owner of project's intellectual property (concept-strategy) / records / data / reports and The Party-2 will have no claim of whatsoever nature over the said property. Hence, the Party-2 will have no right to use / publish data related to the project unless written permission (only for academic and non-commercial purpose) is obtained from the Party-1.

F. Breach of Agreement:

Both the parties shall have right to terminate the agreement with other party in case of a non-compliance with the deliverable as specified under 'Responsibility of Party' in addition to an act of omission or commission which has potential of detrimental impact on the organisations' reputation in general and the prospects of the collaborative project in specific. In such situation

either of the parties can withdraw from MoU with issuing written notice by a respective signatory of this MoU or their successor.

G. Amendments to MoU:

Although the role and responsibilities of both the parties are adequately specified hereinabove, this MoU is open for amendments that may be deemed necessary in the interest of the partnership and the collaborative project. I. Arbitration:

Any dispute arising with regard to any aspect of this MoU shall be settled through mutual consultation.
